- **Detailed analysis of the OH&S hazards** associated to all the activities carried out, so that the risk assessment for health and safety is complete, and the adoption of risk mitigation measures is effective;
- Constant attention to the identification of risks and opportunities, in order to achieve the continuous improvement of the Environmental Management System and the environmental performance of the company;
- Monitoring and reduction of environmental effects from the activities carried out by PERAR;
- Involvement and awareness of all the stakeholders involved in PERAR's activities about the centrality of the HSE issues in the conduct and execution of work, including in meeting customer requirements in HSE.

To implement these principles and objectives, PERAR has adopted an Occupational Health and Safety Management System (OH&S MS) according to the UNI EN ISO 45001:2018 standard, integrated with an Environment Management System (EMS) according to the UNI EN ISO 14001:2015 standard, obtaining certification for both.

The Health, Safety and Environment Management System (HSE MS) thus becomes a basic tool for the functioning of the company as it harmonizes with the Quality Management System. In this way, the whole organization benefits, even in terms of management, and can pursue the continuous improvement of the corporate management system.

To ensure the implementation of this Policy, PERAR's Top Management is constantly engaged:

- to ensure the availability of appropriate human and financial resources;
- to prevent and promptly manage any type of accident or emergency through the application of specific procedures by working proactively with employes, customers and public authorities;
- to train all personnel on issues related to occupational health and safety and environmental protection;
- to promote the participation and consultation of workers and their representatives;
- to *involve the responsibilities of the internal and external partners*, in order to ensure the achievement of the objectives set for quality, the promotion of occupational health and safety and the protection of the environment;
- to ensure that the *Quality, Health, Safety and Environment Policy* is understood, implemented at all levels of the organization and available to the stakeholders;
- to take an active role in promoting and guiding all activities having an influence on quality, OH&S and the environment, in the latter case in accordance with the Life Cycle Perspective approach;
- to ensure proper waste management, giving priority to waste reduction at source and waste recycling.

For these purposes, PERAR's Top Management has set up a specific internal organizational structure which ensures:

- the continuous monitoring of the integrated Quality & HSE management system;
- the application of the Q-HSE Policy, identifying the correct operating procedures;
- the effective application of the integrated management system and corporate policy adopted.
